1. Procedural Matters:

1.1 Call to Order:

The meeting was called to order at 1:31 pm.

1.2 Attendance / Quorum:

Attendance was recorded and a quorum was announced.

1.3 Public Comments:

2. Approve Minutes from March 1, 2022, Meeting:

5. ATEP Update:

Ann-Marie Gabel provided an update on the current and potential tenants.

PJRJPA's planning period ends on August 1, 2022, and then their construction period will begin. The California Environmental Quality Act (CEQA) and site plan are scheduled for the July Board meeting.

The planning period for Advantech ends on September 28, 2022, and their construction period will begin October 1, 2022. The CEQA and site plan for this

tenant will be presented to the Board at the August or September meeting. The request for additional space of 50,000 square feet is still to be determined.

The Access and Option Agreement for Southern California University of Health Sciences (SCUHS) is still being negotiated.

Fencing around a portion of the county exchange parcel will be installed soon. Weed abatement will take place around the site and the City of Tustin has been asked to paint over some graffiti. Security patrols will increase in the area.

The Saddleback @ ATEP building is still with the Division of the State Architect (DSA).

A motion was made by Medhanie Ephrem and seconded by Connie Cavanaugh to approve the 2022-23 Meeting Schedule as submitted. Motion carried unanimously.
