#### 2. BUSINESS MANAGER'S REPORT

## a. PUBLIC HEARING - LAND EXCHANGE

Notice has been served that a public hearing will be held at this time. Copies of the proposed Resolution and the report of the Board of Appraisers are included with the Agenda. It is recommended that the proposed Resolution be approved, authorizing the land exchange between the Saddleback Junior College District and the Mission Viejo Company, and authorizing the President and Secretary of the Board of Trustees to execute the necessary documents including a grant deed.

It is recommended that a fee of \$500.00 be authorized for payment to Cedric A. White, who served as a member of the Board of Appraisers.

#### b. TUITION PAYMENT

We have received a revised tuition billing from the Santa Ana Junior College District during the 1968-69 academic year in the amount of \$148,160.36, which represents the cost of instruction for resident students of the Saddleback Junior College District attending Santa Ana Junior College. Against this amount, a deduction of \$1,258.54 may be made for the expense of instruction of resident students of Santa Ana Junior College District attending Saddleback College, leaving a net amount due Santa Ana of \$146,901.82. It is recommended that payment of this amount be authorized.

#### 2. BUSINESS MANAGER'S REPORT

## INSURANCE LOSS

On February 10, 1970, one of the District's station wagons was extensively damaged. The insurance company has determined that it is a total loss and has offered a settlement of \$3,100.00. This amount was determined by establishing the cash value of the vehicle at \$3,200.00, less the deductible amount of \$100.00, leaving a net of \$3,100.00. It is recommended that this settlement be accepted and that the Superintendent or Business Manager be authorized to execute the necessary documents.
