DISTRICT'S LEGISLATIVE PRIORITIES IN 2023



State Priorities

Workforce Development Pipeline

Partnerships with local industry and workforce development leaders are vital for opportunities for students who are working to earn degrees or certificates. SOCCCD has prioritized advocacy for our students to access apprenticeships, internships, and other prospects to assist in achieving their career goals. This can be accomplished through California's incentives for localities to form partnerships with community colleges. This advocacy work helps to open opportunities for students.

Dual Enrollment / Career Pathway Opportunities

Dual enrollment has increased significantly over the past decade and the California College and Career Access Pathway (CCAP) program is a sound investment for high school students who want to expedite their pathway to colleges or careers. However, several aspects of dual enrollment needs to be addressed, including transportation, access to course materials, and course scheduling conflicts for high school students. SOCCCD has prioritized advocacy for legislation that supports streamlining CCAPs to expand opportunities for students.

Strengthen Student Support through Financial Aid and Student Housing

While the Cal Grant reform to create the Cal Grant / 2 Award was beneficial to providing community college students with needed aid, it does not take into consideration the high cost of living for areas like Orange County. Student housing projects, similarly, are more expensive to complete due to the cost of developing real estate in Orange County. SOCCCD has prioritized advocacy for both the Cal Grant and Cal Grant / 2 programs to be increased commensurate to the needs of students who live in areas with a high cost of attendance.



Federal Priorities

Support Workforce for 21st Century

Irvine Valley College and Saddleback College strive to be on the forefront of workforce and career training, preparing our students for in-demand jobs. SOCCCD has prioritized advocacy for federal policies and programs that provide our colleges with the resources and flexibility needed to create and reimagine programs to fit the needs of employers.

Veterans

SOCCCD supports our student veterans. We have prioritized advocacy for federal policies and programs that provide dedicated resources to student veterans, remove barriers to success, and help sustain services at our colleges.

Basic Needs

Irvine Valley College and Saddleback College students are increasingly confronting challenges in housing, nutrition, transportation, and mental health that impacts their ability to complete their educational goals. We have prioritized advocacy for policies and programs that help students overcome these non-academic barriers and support the student as they work toward their goal.

Deferred Action for Childhood Arrivals (DACA)

DACA students are valued members of our college communities and we welcome them in their educational pursuits. SOCCCD has prioritized advocacy of federal policies and programs that continue to allow these students to pursue their educational goals without fear of deportation.

Capital Support for Students

SOCCCD has prioritized advocacy for innovative ways to expand course offerings and services on-campus that support a welcoming and conducive learning environment. Such expansions can be accomplished through support of infrastructure, campus amenities, or support for specific program needs.

The district continues an ambitious construction schedule, bringing significant improvements to all the campuses. The improvements help students feel welcomed and enhance the learning experience.



Saddleback College

Saddleback College has been serving students for 55 years and boasts more than 500,000 alumni. With its rich tradition, Saddleback College offers a rewarding educational environment, with hundreds of associate degrees and certificates available for students. It is a leading community college in transfer rates to the University of California system.



Saddleback College's Advanced Technology and Applied Science (ATAS) building opened in August 2022. Its 52,100 square feet are dedicated to career technical areas, such as manufacturing, architecture, electronics, and graphic communications.



Irvine Valley College

Irvine Valley College offers a small-college environment, modern facilities, with a friendly and dedicated staff. IVC became an independent college in 1985, and has evolved into a flourishing campus, with extremely successful students. IVC has the highest rate of students transferring to four-year schools out of all 116 community colleges in the state.



IVC's new Arts Village, opening in spring 2024, will house the fine arts, music, dance, arts history, labs, practice rooms, and a gallery. It will consist of three new buildings totaling 62,471 square feet and a central garden quad area.


