13. CHANGE ORDER NO. 2: ADD AIR CONDITIONING & VENTILATION FOR PCT LAB, PHYSICAL SCIENCE BUILDING: IRVINE VALLEY COLLEGE

ACTION

INTENTION TO LEASE REAL PROPERTY FOR PRIVATE 16. EDUCATIONAL PROGRAM: IRVINE VALLEY COLLEGE

ACTION

It is recommended that the Board of Trustees adopt the resolution to declare its intent to lease for five years with an option to renew for an additional five years, one year at a time, a parcel of land at Irvine Valley College to house a program of study noncredit accelerated English international students to intending matriculate at American universities higher education.
