Motion by Trustee Moore, seconded by Trustee Hueter, APPROVE AGENDA to approve the Agenda with an additional item (reading of action taken in closed session). Motion carried unanimously with Trustee John Connolly absent (as was Student Representative Brian Bell).

Trustee Swanson read the action taken in closed ACTION TAKEN IN session at the last meeting: The Board of Trustees CLOSED SESSION on March 24, 1986, took action to approve a memorandum of understanding, dated February 28, 1986,

regarding sabbatical leave calculation, and further took action not to approve a provision contractual sabbatical leave replacement, and a provision for any form of unused sabbatical leave from the 1985-86 academic year to the 1986-87 academic year.

On March 24, 1986, the Board of Trustees approved Dr. Cal Nelson's request to be reassigned to teaching. description The position for the District Director/Research and Data Processing has, therefore, been modified at the Board of Trustees' suggestion, and as shown in the exhibit which is made a part of these Minutes. Trustee Gellatly stated that she preferred this position not be filled at this time, but that a study be done - not to determine what this department already does, but what it needs to do. Motion was made by Trustee Moore, seconded by Trustee Hueter, to approve this item, with modification (to wit: "The Acting Chancellor recommends that the Board of Trustees authorize the recruitment of an Acting District Director whose appointment will be considered by the Board of Trustees at the April 14, 1986, meeting. The recruitment of a continuing Director will be held subject to a study of functions and responsibilities of the position"). After discussion, a vote was taken and the motion carried unanimously.

Because Acting Chancellor Habura received no requests to modify the 1985-86 budget, and because there were no recommendations for the Board at this time on the 1985-86 Budget Revision, it was suggested to proceed to Agenda Item IV.

President Walther called for a recess at 3:00 p.m. The meeting reconvened at 3:20 p.m.

Trustee Walther stated that because it was the intent to keep budget cuts as far away from the classroom as possible, that any reductions in expenses would not damage recruitment, enrollment, retention, and service to students, and that, furthermore, the recommendations would, because of wanting to keep the cuts as far from the classroom as possible, begin at the District level, but reductions would not be limited to District functions; also that the colleges have to take some cuts if that became might President Walther asked that if any necessary. functions were recommended for elimination, that the recommendation be justified and a suggested alternative be provided.
